Institutes for Speech Teachers and Coaches

Don't forget the Institutes for Speech Teachers and Coaches, to be held this summer. On July 9, James H. McBurney, Dean of The School of Speech, Northwestern University, will lecture on forensics. On July 23, Rosamond Gilder, noted New York dramatic critic, author, and editor, will lecture on dramatics, and on July 30, M. D. Steer, Director of the Speech and Hearing Clinic at Purdue University will lecture on Speech correction. See the enclosed bulletin for complete program. Remember—these institutes are designed to help you. Plan now to attend.

Change in Speech Institute Program

Following considerable discussion of the merits and shortcomings of our present institute programs, the Board recommended a new institute pattern for next year. Rod McPhee, Ron Gee, and the district chairmen are meeting speech and drama personnel of the nine Wisconsin State Colleges, in an attempt to secure their cooperation in co-sponsoring district drama, debate, and/or speech workshops at appropriate times during the next school year.

It is hoped that by having more institutes, nearer to the schools involved, and concentrating on one phase of speech at a time, our institute programs may be made more helpful to our members. If you have any suggestions for these meetings, notify your district chairman.

Board Decisions Put in Standing Rules

At the March meeting of the Board of Control, the board formalized into rules some of its previous actions which had never been incorporated into our Standing Rules. These include:

- I. 18 No school or contestant may participate in any official contest of the Association without actually attending the contest in person.
- I. 10 Individual awards shall not be given at district and sectional contests.
- IV. 3 There is no minimum time limit for declamations or orations. The discretion as to whether or not the length is suitable is left to the judge.
- V. 4 There is no rule prohibiting a student from changing his declamation or oration as he progresses from one contest to the next.

Increase in Association Dues

After considerable discussion of the financial status of the Association and various formulæ for adjusting income to meet expenditures, the board voted to increase the dues \$2 per school, thus establishing the following dues structure for 1954-55:

- \$7.00 for schools with enrollment of 149 or less
- 9.50 for schools with enrollment of 150 to 349
- 12.00 for schools with enrollment of 350 or more

Limit League Speech Entries

Following considerable discussion of the Colby-Wicklund poll concerning league practices, (see p. 14 November 1953 News Letter) the board voted to repeal Standing Rule I, Paragraph 13, (September 1953 News Letter) and substitute in its place:

The maximum number of contestants each school may enter in each event of the league speech contests shall be two.

It is intended that this rule will minimize some of the differences which have existed among the many leagues and also have the effect of keeping the state speech contest from becoming too large.

Three Judges in State Drama Contest

The board voted to continue the use of three judges in the 1954 State Drama Contest. The entry fee for the contest will remain at \$15.00 for each school. The board suggested that the secretary-treasurer attempt to provide the judges with an opportunity to present an informal evaluation of the drama contest as a whole before the group as well as to give specific written comments to each coach.

Questionnaire to be Sent to Schools

In an attempt to identify significant attitudes and reactions to our present debate and drama programs, the board authorized the secretary-treasurer to prepare and circulate a questionnaire. We are attempting to discover why many of our members do not participate in these activities, as well as attempting to get suggestions for improvement from those schools which do participate. These programs are being operated for you and your students, so please be sure that your school responds to this questionnaire.

Referendum on Debate Proposition

The Board of Control voted to continue the procedure followed in past years to choose one official debate proposition in the fall and announce the proposition at the same time the Wisconsin-Marquette debaters are notified to prepare for the Teacher's Convention debate. An advisory referendum as to the choice of the proposition will be sent out early in the fall to those schools which actually entered a debate team in WHSFA competition this year. This reflects a change in board policy this year, decided upon at the March board meeting. Previous debate referenda were conducted among all schools checking debate on the registration card. Future referenda will be limited to those schools which entered a team in WHSFA competition the previous year.

A committee, appointed by the chairman of the board, will make the final decision on the question.

Rule Revision Affects Debate Coaches

In the past debate coaches attending the state tournament have been asked not to attend any of the rounds of debate. The board changed this to permit coaches to attend the final round by revising Standing Rule III, Paragraph 11 to read:

Coaches are asked not to attend any but the final round of debate at the state contest.

The board also voted to continue the practice of having judges at the state debate contest give no oral critiques until the tournament is completed.

Situation in Northern Section

Acting upon a request from debate coaches from 14 schools in the Central Section, the board discussed the equity of allowing schools in the Northern Section to proceed to the Sectional drama and debate contest without first going through a district contest.

After lengthy discussion the board decided to study the matter more carefully before taking any action. Mr. Robinson was urged to discuss this problem with coaches in the Northern Section. This item will be placed on the agenda for the November Board meeting.

Plan Now to Enter Discussion Contest

The board voted to include tape-recorded panel discussion as a regular activity next year. No awards will be given. The contest will be run in the early fall and will operate in a manner similar to this year. (See p. 7, February 1954 News Letter).

This year ten schools were entered in the contest. All of the coaches involved were asked for their reactions at the close of the contest, and all of them indicated a desire to enter next year. Although we limited the number of entries this year because it was an experiment, next year the contest will be open to all schools that wish to enter. So plan now to participate in the association's newest sponsored activity, discussion. Further details of this contest will be sent with the September News Letter.

Drama

Drama work should begin early in the school year since the name of the play to be used in the drama contest must be registered with the secretary-treasurer on or before October 15th. A new list of Approved Plays 1954 (Yellow cover) is being sent to each member school with this News Letter. Please discard all old play lists you may have in your library as some of the plays have been discontinued and some new ones have been added. Do not use any list which does not have Wisconsin High School Forensic Association--1954 on the cover.

We cannot stress too often or too much the importance of selecting a play long before it is to be produced. Selections made under pressure, or under requirement to meet a deadline, are seldom wise selections.

State Debate Tournament

Marquette High School of Milwaukee emerged from this year's State Debate Contest as undisputed champions, with a record of 8 wins and no losses. The winning debaters were William Farrell and Kenan Kersten, affirmative, and Joel Jobst and Lawrence Bugge, negative. For Kersten and Bugge it was the second straight state championship, as they were members of the Marquette squad that tied for first place last year. The debaters were coached by Father Thomas Curry, S. J. Marquette debaters will represent Wisconsin at the National Speech Tournament this June. All of our best wishes for their success in this tournament!

Second place was awarded to Amery High School, with a record of 6 wins and 2 losses.

Third place was shared by the debaters from Eau Claire Senior and Wausau, with identical records of 5 wins and 3 losses.

Play Writing Contest

The Wisconsin Idea Theatre announces a play-writing contest for high school students and teachers, conducted in cooperation with the Wisconsin High School Forensic Association. During the past two years the Idea Theatre has offered a single prize for the best original play submitted in conjunction with the State Drama Contest. This year, however, six cash prizes will be offered in two separate categories, and writers of scripts given honorable mention will receive subscriptions to Wisconsin Stage, official publication of the Wisconsin Idea Theatre.

The contest this year will have two divisions: one for teachers, and one for students. In this way the competition will be more evenly balanced. A total of \$75.00 will be awarded in each division: 1st place, \$40.00; 2nd place \$25.00; and 3rd place, \$10.00. A panel of three judges will determine winners and placings in each division.

Following are rules for the contest:

- (1) Each contestant may submit only one entry.
- (2) All entrants must be residents of the State of Wisconsin.
- (3) Students and teachers in any accredited private or public school are eligible to compete.
- (4) Manuscripts that have been previously published will not be eligible for consideration.
- (5) Entries must be 15 to 35 double-spaced typewritten pages in length.

- (6) All entries should be typewritten on one side of standard 8 $\frac{1}{2}$ "x11" paper.
- (7) The Wisconsin Idea Theatre reserves the right of limited publication of any of the entries submitted.
- (8) The Wisconsin Idea Theatre reserves the right to edit all works submitted, and to rewrite any parts which, in their judgment, should be changed to facilitate production.
- (9) The decision of the judges shall be final. No duplicate prizes shall be awarded, and no payment whatever shall be made for manuscripts which do not qualify.
- (10) All entries must be postmarked on or before December 31, 1954.
- (11) Each manuscript must be accompanied by an entry blank which may be obtained upon request from the Wisconsin Idea Theatre, Room 3026 Stadium, Madison 5, Wisconsin.

Coaches Pleased With Debate Tournament

The State Debate Tournament had a "New Look" this year. The tournament had four rounds of debate instead of three, lasted two days instead of one, and featured a Friday evening banquet rather than a Saturday noon luncheon.

Since these changes were quite basic we felt it desirable to ask the coaches involved how they reacted to the new system. Following are selected quotations from their replies:

"We liked the two-day tournament with four rounds very much, and we all enjoyed the banquet. In fact, we think the set-up is ideal!"

"We are in favor of a two-day four-round tournament. Would prefer a luncheon Saturday noon at which time the winners could be announced."

"Four rounds in two days is a big improvement. Friday night banquet ideas is fine and was wonderfully carried out this year."

"Four round two-day schedule makes for the best kind of debating--relaxed debating. The banquet was excellent, but--basically to long."

After considering these reactions the board of control voted to use the same format in 1955.

In view of the high costs of the State Debate Contest the registration fee will be \$20 exclusive of contestants meals.

FROM THE NUEA ANNUAL REPORT--1953-54

For one quarter of a century, the NUEA has been encouraging free discussion and debate of public questions by high school students in every state of the union. Almost every vital topic of our generation has been considered by the NUEA Committee on Discussion and Debate Materials and referred to its members and affiliates for their recommendation. Out of this careful and democratic process of selection has emerged twenty-five annual problems for which our committee has prepared and chosen a wide variety of study materials. These materials have been used by the boys and girls of our high school debate squads, some of whom now sit in our state and national legislatures and hold responsible executive positions in government. Of the twenty-five issues discussed and debated, some have been resolved by subsequent legislation while others are still as current as the day's newspapers.

State Speech Contest

Following are the ratings given at the State Speech Contest which was held on the University of Wisconsin Campus on Saturday, April 10. Of the 758 students actually participating, 357 received A's, 359 received B's, and 42 received C's. Last year with 733 students entered 321 received A's, 337 received B's, and 75 received C's.

This makes this year's contest the largest in Association history in the number of contestants involved, and the second largest in the number of schools involved (277). Last year we had three more schools.

The September News Letter will list titles of selections used. Medals won at the state contest are now being mailed out.
