Platteville District, Mr. Harold Gall, Principal at Lancaster High, for a one-year term, succeeding Kenneth Holt, who left the profession.

River Falls District, Mr. Louis Berg, Principal at Baldwin High, for a three-year term, succeeding F. M. Robey.

Stevens Point District, Mr. J. C. Gillmann, Principal at Marathon High, for a two-year term, succeeding A. D. Wicklund, who left the district.

Minutes of the 30th Annual Meeting-WHSFA Brooks Memorial Union, Marquette University Milwaukee, November 2, 1956

- 1. The meeting was called to order by Chairman K. A. Curran at 2:00 P. M. with 65 persons present.
- 2. The reading of the Minutes of last year's meeting was dispensed with, and they were approved as printed in the November 1955 Newsletter.
- 3. The Chairman announced the results of the election and introduced new Board members who were present.
- 4. The Secretary-Treasurer reviewed the Minutes of the Annual Meeting of the Board, held Wednesday, October 31. (See various articles in this Newsletter).
- 5. The Secretary-Treasurer explained the reason for the late announcement of the debate topic and apologized for the inconveniences it caused.
- 6. The Chairman asked for questions, comments, and suggestions from the floor.
  - a) Mr. Melzer asked that the state office do all it can to minimize the conflicts in dates of the spring music and speech contests. Mr. Barnes, a member of the Board of Control of each association, and Mr. Christ explained the difficulties of scheduling these various contests without conflict.
  - b) Mr. Helstad asked if the procedure for selecting the debate topic could be speeded up.
    The Secretary-Treasurer agreed to advance
    the time schedule next year so that the final
    announcement could be close to October 1.

- c) Mr. Dunwiddie and Mr. Helstad expressed concern regarding an understanding by the Board of Control of requests and proposals which come from the coaches; collectively, and individually. Mr. Schacht explained the necessity for compromising the various wishes of groups of coaches or individuals with the best interests of the entire program, and with varying local conditions.
- d) One coach raised the question of communications between the state office and the coaches, and asked if those matters directly affecting the coaches could be sent to them rather than the principals. Chairman Curran pointed out that the WHSFA is an association of schools, and that communications should, therefore, be sent to the principal administrator of the school, and coaches who feel they are not getting communications referred to them should take the matter up directly with their own administrators.
- 7. The meeting adjourned at 3:00 P. M. for the annual debate on the high school proposition between the University of Wisconsin and Marquette University.

#### Speech Institutes

Over 600 at Oshkosh: Over 400 at Stevens
Point! Such are the reports being received from
successful speech institutes which have already been
held at the state colleges in La Crosse, Oshkosh,
Stevens Point, Superior and Whitewater. As a followup to its drama workshop (see article by Mrs. Julia
Mailer, page 12), Whitewater has scheduled another
institute, this one on debate and speech, for November 15th. The La Crosse drama and debate institute
will be followed by a general speech institute in
January. At Oshkosh, four University of Wisconsin
debaters presented a demonstration debate on this
year's question before more than 200 debaters and
their coaches.

#### Special Workshops Held

On October 20, the WHSFA cooperated with the Wisconsin Idea Theatre in putting on a day-long theatre workshop at Manitowoc High School. Here students and teachers worked together to learn more about the fine points of acting, scene construction, play selection, direction and production. An interesting outgrowth of this workshop was the organization of a high school division of the Wisconsin Idea Theatre. Mr. George Kanzelberger of Manitowoc is serving as temporary chairman of the group which is now in the process of formulating its constitution.

From Wisconsin State College at Eau Claire comes word that 170 students from Wisconsin and Minnesota high schools met at the college on October 20, to take part in the 10th annual Discussion Clinic. The 10 best discussors at the clinic were honored, with Michael Case of Prairie du Chien Campion winning top honors.

#### Tape-Recorders Ready to Roll

What should be the policy of the federal government in regard to agriculture?

This is the question on which 16 member schools of the Association have committed a discussion to tape-recording. These 16 schools will be divided into sub-groups for an elimination, which will determine the best discussion in each group. By the time you receive this newsletter, judging of the sub-groups by single judges will be underway. The highest ranking school in each sub-group will receive a certificate of merit and enter the final round, to be judged by three judges.

Individual medals will be awarded to the top three schools, and a school plaque will be presented to the school with the winning tape.

#### Committee to Study Proposed Contest Changes

The chairman of the Board of Control has appointed a committee to study the present program of the Association and any suggestions for its improvement. The committee, composed of Mr. Christ, Chairman; Mr. Marquardt, and Mr. Carlson will review ideas which have been solicited from coaches and teachers of the state colleges and universities, as well as from the principals and coaches of the high schools. Send your ideas for rule changes, contest additions or subtractions, procedural suggestions, etc., to your district chairman or to the state office. The sooner they are received, the more considered judgement they can be given prior to the March Board meeting.

### Poll, Professors Pick Parity Proposition

The official Wisconsin debate proposition chosen by a special committee of:

Professors Haberman, Weaver, Brockhaus and Brembeck, on the basis of an advisory poll of debate schools is

Resolved: that the federal government should sustain the prices of major agricultural products at not less than 90% of parity.

The polling resulted in the closest vote on record since the inauguration of this method of choosing the question. The parity question received 15 firsts, the soil bank proposition 14 firsts, and the Brannan Plan 13 firsts. 22 of the schools registered in debate did not vote.

Help Wanted!

We have not said much about high-school drama since the review of John Dietrich's stimulating lecture on that subject just a year ago. As we travel around the state and talk with our member friends, we find that there is great need to bring this subject up for discussion again. The need is evident from the questions we receive, not only at the institutes, but in our correspondence here at WHSFA. It seems that too many drama directors feel inadequate in selecting a play and plotting the business; in costuming, designing, lighting, and publicity. These techniques are not easy to learn and in the case of the very successful high school director, we find that he has had two or three years of good college experience behind him. But, does the average teacher have that special theatre training? If she does not, what can be done to help her?

Those people who were at the Speech section of the S. W. E. A. in Madison last February will remember that Mr. Gauger talked at some length on how the University might help. However, nothing has really crystallized in our planning and thinking.

This fall we have seen some very useful and stimulating theatre workshops; one at Whitewater and one at La Crosse State College. La Crosse offered the high school students a choice of debate seminars and theatre workshops. At Whitewater the students spent the whole day in actual theatre activities. In both programs, there was real and practical help given to the teachers and the students. They directed, painted sets, made up characters, planned posters and sold tickets. We applaud both of these efforts and hope for many more.

It seems fairly clear that the greatest technical help for high school theatre directors can come by meeting at the theatre buildings in the different state colleges, where flats, grids, levels, spots, and floods can be demonstrated objectively, and where the best people in theatre will be willing to give their time to teach and demonstrate. The state colleges have already shown their willingness to give help in this field. But more can be done. Let's do some thinking about this. Write to the WHSFA office, or to the drama staff at the colleges. Talk over your needs with others in your district, and then let your district chairman know what you need. Let's work for better high school theatre productions in Wisconsin.

## Cuttings from Longer Plays to be Included in One-Act Play List

The Wisconsin Idea Theatre has again been asked to prepare the official one-act play list for 1957. One innovation in the new list has been authorized by the Board of Control. The 1957 list will include longer plays as well as the traditional one-acts. HOWEVER, the contest will continue as a one-act event. This means that a scene or act may be cut from the longer plays on the list. The responsibility for making a cutting appropriate to the suggested time limits (25 to 35 minutes) will devolve upon the schools selecting the longer plays. It is hoped that this move will give play directors a greater variety of good drama from which to make their choice.

Coaches are again asked to send suggestions for additions or deletions to Professor Robert Gard, Wisconsin Idea Theatre, Stadium, University of Wisconsin, Madison, Wis.

#### And Still More Help for the Play Director

We have a newly published three-act highschool play list to offer our WHSFA members. This list has been carefully compiled, with consultation from the Wisconsin Idea Theatre, the Speech Department of the University, and successful directors in community theatre in Wisconsin. It offers 150 plays with a short synopsis, information about the cast, royalties and sources of production copies. The <u>list</u> costs 25 cents, and if you wish to buy it, write to the Bureau of Information and Program Services, Memorial Library, University of Wis.

Examination copies of the plays may also be borrowed from BIPS.

## "C's" Still Possible in League Speech Contests

Since a number of leagues have been awarding trophies on a point basis involving the use of "C" ratings, and since the application of the new rule eliminating "C" ratings to these contests would upset long-established policies and procedures, the Board ruled that the new rule was not intended to apply to league contests, but only to district and state speech contests.

#### New Rule for Debate Contests

We call your attention to the new rules governing debate contests. Schools desiring to use more than four debaters may do so by designating in advance the names of all debaters and alternates on the new registration form.

#### They Must Like Madison

As we again prepare to welcome the "champions" to the state drama and debate contests for 1956-57, our attention turns to what schools might be making the trip to Madison for the first time. In the past ten years, 62 Wisconsin High schools have brought their one-act play to Madison, and 50 schools have had the experience of debating in a state tournament. With an average of 12-15 plays and debate teams here annually, this, of course, means that there have been a number of "repeaters." We thought you might be interested in which drama and debate schools have been here most often. Eau Claire Regis, Milwaukee-Marquette, and Superior Cathedral have reached the oneact finals for the past five consecutive years, while the same record in debate has been achieved by Eau-Claire Senior and West Bend. Through the past ten years the list of most frequent repeaters looks like this:
