Computers to be Trialed in Extemporaneous Prep Room in 2010

The Board of Control at their September 15, 2009 meeting decided to follow the national trend and allow students to use their own lap tops in the Extemp Prep Rooms. The following guidelines have been set up for this trial

Extemporaneous Speaking Rules for Computer Use in Preparation Room

- 1. There is no use of power plugs in the Extemp Prep Room allowed at all, at any time. The only power for a computer inside the Prep Room is to be from batteries.
- 2. No connectivity from students' computers of any kind is allowed inside the Extemp Prep Room. For example: no internet, no IM'ing, no outside servers, no cell phone tethers, etc.
- 3. Students cannot use a computer to prepare speeches. They can use the computers to search and read, but cannot write speech or organize thoughts on computers.
- 4. Students are prohibited from accessing outlines and speeches on the computer prepared prior to their draw time.
- 5. Any student using a computer must be prepared to show prep room or festival staff what they are accessing at any time. Any student not providing festival staff with the information they request may be disqualified.
- 6. Students should be aware that they are subject to extensive monitoring of their computer use.
- 7. Students cannot access audio, video, or other multi-media files during preparation time.
- 8. Students cannot use their computers from the time they leave the Extemp Prep Room until they have completed their speech. Students may take their computers with them to their assigned speaking room, or to lunch, but cannot use the computers outside the Prep Room until after their speech is completed. Any student using the computer in the hallways or classrooms prior to their speech may be disqualified.
- 9. WHSFA may put stickers and/or tape on computers to ensure they are not used, or to ensure appropriate owners take their own machines.
- 10. WHSFA does not assume any liability for computers. Students, parents and coaches should be aware that the students are bringing and using the computers at their own risk. The WHSFA is not responsible for lost, stolen or broken computers.

Ethel Heise New Coach Award

One coach will be selected each year and will be presented with a plaque by the Executive Director of WHSFA at a local school board meeting.

DEFINITION OF A NEW COACH

A "new" coach is defined as someone who has completed one to five years of coaching.

WHO IS ELIGIBLE

A forensic coach who is doing exceptional work as exemplified by:

- Number of students involved in forensic program as juxtaposed with the size of the school.
- The quality of the student performances at the WHSFA State Speech Festival as indicated by the number of students receiving gold, silver and bronze.

WHO CAN NOMINATE

- 1. Fellow coaches
- 2. Current and/or former students
- 3. Parents of current and/or former students

- 4. Administrators and/or Supervisors
- 5. WHSFA District and Sectional Chairs

CANDIDATE MUST SUBMIT THE FOLLOWING

- Three Letters of Recommendation: one letter must be from a current and/or former student or a parent of a current/former student. The other two letters can be from fellow coaches, administrators, supervisors, colleagues, WHSFA District Chair or WHSFA Sectional Chair.
- 2. An Essay: "Why Do I Coach?" The essay would be in a 12 font, with 1" top and bottom margin, 1.25 left and right margins and not exceed two (2) pages.

- 3. Animal Story
- 4. A Story about Teamwork

PUBLIC ADDRESS:

- Same-Sex Marriage: To what extent, if any, should state and federal government recognize same sex marriage and/or civil unions?
- 2. Vegetarian/Vegan Diet: What are the benefits, if any, to a vegetarian and/or vegan diet?
- 3. Obama Presidency: To what extent, if any, has the first year of the Obama Presidency been a success or failure?

Tackling the Teaser for Prose and Poetry Reading

"My eccentric forensics coach sweeps about the room, humming loudly, while checking my teammates' progress. I glance from the corner of my eye at my play-acting partner, and sense that she is just as nervous to see Coach approaching as I am. If only we'd listened to her when she told us we needed more practice..."

Of course, the aforementioned scene captured through the eyes of a student is a little too familiar. Even as a coach, it seems that the forensics season just has this way of creeping up on me before I'm ready to help students choose pieces, practice, or compete at their first tournament. And while it is inevitable that this season too will most likely catch me before I'm one hundred percent ready for it, I did not write the previous paragraph to launch into a discussion about my procrastination.

Instead, I wrote the first paragraph to serve as an example of what is often referred to as a "teaser." A teaser is like a narrative hook in writing, in that it is used to grab the attention of the audience. It introduces just a taste of what is to come and then leaves you hanging, wanting more. However, instead of being embedded within a speech or text, a student uses a teaser by performing a small excerpt, usually no more than one minute in length, of an interpretive selection (ie. prose, poetry, etc.) before delivering their introduction. The introduction is then delivered, and the performer continues with their presentation.

Many competitors enjoy implementing the teaser into performances, as it allows them to be in-character from the moment they

set foot in front of the audience. Certainly, competitors still understand the value of the introduction, and the opportunity it provides to recognize the author of the chosen selection. However, delivery tends to be more natural when students use teasers. Furthermore, the tone established for the audience tends to be more exciting when using

a teaser. Audience members tend to feel more connected to the performer because there is a degree of mystery in using a teaser, as it leaves the audience wanting to know how the excerpt will pertain to the remainder of the selection.

Finally, the reason I address the use of the teaser is that it is currently an integral part of performing interpretive events on the collegiate forensics circuit, and I am now seeing this trend entering the high school circuit as well. I feel that to most Wisconsin high school forensics competitors, their coaches and judges, the teaser is relatively unexplored territory at this time. However, given a few years, I believe it is a trend that will truly take hold. Thus, I encourage coaches to inform students and judges about teasers so that everyone can feel just that little bit more ready for the season at hand.
