Malone Presents at National Conference



Schools May Enter Six Groups in Speech Festival.

Beginning this year each school may enter up to six groups between Group Interpretation and Play Acting, not to exceed four groups in either category. Schools choosing to enter six groups will have to select a Saturday Time Slot at The State Speech Festival in exchange for having the additional entries. The total number of entries for a school is still 25.



Outstanding Crew Award Added to State Theatre Festival


With the changes in the time for One Act Play Festival, WHSFA has been able to add another award for students. In the past, there was no way to recognize the crews that do an amazing job of setting up and striking the set. Now with the school

having 45 minutes of time to be used in any way the school deems necessary, the judges will be in the room to watch set up and strike and be able to recommend the school for an Outstanding Crew Award.

Middle Level to Test New Rubrics

The Middle Level Advisory recommended to the Board of Control that some of the Level I and Level II Festivals experiment with new rubrics this year. The Advisory felt that the old rubrics were often difficult

for the judge and the student to interpret. Nancy Herbison offered to try out some new rubrics at Level I and Level II and report back to the Middle Level Advisory on the rubrics effectiveness.

2012-2013 Speech Topics

Oments in History: 1901-1913 Turn of the Century to the Eve of the Great War

Public Address:

- Sports Related Head Injuries: What, if anything, can/should be done to reduce concussions and brain injuries caused by sports/athletic participation?
- Political Partisanship: What, if anything, should be done to reduce the level of partisanship in state and national government?
- Great Lakes: To what extent, if any, should the Great Lakes Commission consider the sale or sharing of water with other parts of the continent?
- The Draft: To what extent, if any, should a military draft be re-instituted by the U.S. government?

Storytelling

- A story from Greek or Roman mythology.
- A story involving a ghost.
- A war or military story.
- A story involving trikery or deceit.

Special Occasion:

- You are to present a book talk on at least two books for younger students to the local book club or local library board for a summer reading program.
- You, as maid of honor or best man, are to speak at your siblings wedding.
- You are to present a speech at a local organization about your recent experience as a foreign exchange student.
- You are to address your local school board concerning a school policy students want to change.

Book a Slot for State

Last year WHSFA found that having "Book a Slot for State" was a success. This year the on-line registration will open on November 1, 2012. After a session is full (i.e. 5:30 Friday) the system will ask the school to select a different time slot.

Middle Level Readers Theatre and Play Acting to Have Time Limit Change

Beginning the 2013-2014 school year, the time limit in Readers Theatre and Play Acting will be changed to 12 minutes instead of the present 15 minutes. It was the feeling of the Middle Level Advisory that it would make it easier for schools to set up a schedule and more closely mirror Senior Level Speech. Remember: it does not begin until next year.
