

Board of Control Holds Fall Meeting

The Board of Control met in Madison on October 23-24, 1984, with a special session beginning at 4:00 p.m. on October 23 to view a demonstration by Terrence Falk of Juneau High School in Milwaukee of his forensic scheduling computer disk designed particularly for multiple-round contests and tournaments (see story this issue). HINTZ AWARD REQUIREMENTS CHANGE

With the state speech award system change from "A," "B," "C" grades to "Finalist," "All State," and "Critic's Choice," a new method of determining winners of the "Hintz Award for Excellence in Speech" had to be determined. A committee, consisting of Robert Scott and James Dottke, studied the matter and presented a proposal which was slightly modified and accepted by the Board at its fall meeting. For the contest held April 19-20, 1985, the following procedure will be in effect:

Each state participant receives one point, Each "All State" award receives two additional points, Each "Critic's Choice" award receives three additional points.

The point total for each school will be determined, and the top five per cent of schools participating will receive this award. The winners will be notified and schools receiving the award will be announced in the May Newsletter.

The award was referred to the Speech Advisory Committee for further study after this one-year trial period.

SCHEDULING CONTESTS BY COMPUTER

Terrence Falk, a forensic coach at Juneau High School in Milwaukee, has developed a computer program for the scheduling of multiple-round speech contests and tournaments. He explained and demonstrated how it works to the Board of Control at their fall meeting.

The program's needs are an Apple II Plus, or IIe, or IIc, a monitor, a one disk drive, and a printer. According to Falk, "You do not need to be a computer wizard in order to run this forensic program." He suggests that a couple high school students may well be able to do it for you, but that, if you do handle an Apple Computer on a regular basis, you should not have any difficulty.

LOSS OF INSTRUCTIONAL TIME SURVEY

Public schools throughout the state of Wisconsin will soon be receiving a survey asking them to document the time spent out of the classroom by students taking part in athletic, music, and forensic activities as well as on field trips or other school-planned programs. As the legislature is moving toward the definition of a school day including a required number of hours of face-to-face instruction, the information gathered in this survey will help all the co-curricular activities more carefully plan their activities. While the survey is being mailed and processed by the Department of Public Instruction, it is a co-operative project of the Association of Wisconsin School Administrators, Wisconsin Association of School Boards, Inc., Wisconsin Association of School District Administrators, DPI, Wisconsin High School Forensics Association, Wisconsin Inter- scholastic Athletic Association, and Wisconsin School of Music Association.
