STATE SPEECH FESTIVAL - APRIL 16-17, 1999

The State Office has sent a time preference card for the 1999 WHSFA State Speech Festival to all member Speech coaches. The card must be returned to the State Office no later than October 31st. In November the cards will be divided into groups according to first preference. We will draw ninety (90) cards from each group. You will be notified which time slot you received. Important things to remember:

NATIONAL FEDERATION MEETING

WHSFA BOARD OF CONTROL FALL MEETING

The WHSFA Board of Control met on Wednesday, September 9, 1998 in Madison.

- New board member Charlie Krupa, Principal, Necedah High School, was welcomed. Charlie is the new District 8 Chair.
- Roger Foegen, Bangor, was elected new Board Chair (Foegen takes over for Roger Klug who retired from the Board last spring).
- Walter Daumler, Delavan-Darien, was elected new Board Vice Chair.

Theatre:

The Oral Evaluator feedback form will be used at the State level beginning this year.

UW-Whitewater will host the Wisconsin High School Theatre Festival on November 19-20-21, 1998.

Debate:

All debate coaches will receive a copy of the NFL's *Standards for Evidence Citation*, which has been adopted by WHSFA.

Speech:

In order to clarify specific issues, changes/additions were made to certain category

evaluation sheets (see Speech Handbook Addendum for details).

**To take effect at WHSFA State Speech in the 1999-2000 school year:** All schools with 13 or less entries will be required to provide one judge. All schools with 14 or more entries will be required to provide two judges. All schools not providing judge(s) will be charged \$75 per judge.

Middle Level:

Middle Level survey results: The majority of schools responding wished to keep the Level I and II hosting duties on a voluntary basis rather than assigned by geographic location. Regarding the development of a WHSFA Middle Level Debate program, the consensus was a resounding "NO".

Other Business:

District Debate Tournament sites/hosts are now being established for the 1998/99 debate season.

The WHSFA Spring Board Meeting will be held on April 29-30, 1999 at Heidel House in Green Lake (in conjunction with the spring WCA meeting).

THEATRE ADVISORY...

The WHSFA Theatre Advisory Committee held their annual meeting at UW-Whitewater on July 2, 1998. In attendance were members Craig Lewis, Amy Tubbs, Rick Braun, Sue Luterbach and Chuck Malone. Presiding over the meeting was Skip Grover, Advisor to Theatre. J. Peter Shaw and Deb Flanders from the WHSFA State Office also attended.

The committee reviewed the 1997 Theatre Festival and updated plans for the 1998 Festival. The committee made a motion to use the Oral Evaluator feedback form at this year's State Festival. Member comments and concerns were also discussed.
