DEBATE TOPIC RESOLUTION FOR 1990-91 MODIFIED

At the National Federation Debate Topic Selection Committee meeting held in Little Rock, Arkansas on August 3-5, the delegates voted to modify this year's resolution to add the words "beyond the earths mesosphere." The resolution now will read:

Resolved: That the United States government should significantly increase space exploration beyond the earths mesosphere.

EDITORIAL

STATE SPEECH REFLECTIONS

Even the rain didn't seem to dampen the spirits of the 5000 high school students who were in attendance at the State Speech Festival last April 27-28 held in Madison. Mine was not dampened either. The last time I wrote you, I was not a "happy camper," as the vernacular goes. This time, I write with a much happier heart.

Yes, there were the injuries, the hurt feelings, the lost and misplaced students, the frantic coaches, the traffic jams, the late rounds, the irate parents, and the seemingly inevitable running out of tee shirts, all of which seems to go with the territory. More importantly, there were positive things that made this festival meaningful.

Having judges sessions before each round apparently improved the fairness in which students were adjudicated. In other words, everyone received the same information.

The use of judges provided by schools also improved the quality of the event. Not only did this mean that the hired individuals were not overworked, but a fresh new, understanding personality for students was able to be provided.

The diversification of responsibilities for Friday evening and Saturday morning between Advisory personnel, Board of Control members and State Office staff made it possible for all of us to spend more time with you. That is important!

Former Board of Control members as well as present ones were in attendance, and participated by both helping where needed and attending various events to get a "firsthand look" at what was going on.

The use of Bascom Hall for Headquarters has apparently improved the ability for coaches, students, bus drivers and parents to have a more central location for getting together.

Lastly, I am very happy to tell you that in the final swing through Bascom 260 and 272, it was only necessary to pick up six pop cans and 12 sheets of paper. What an improvement.

PLAN NOW FOR STATE SPEECH

No, this is not a rerun of the March 1990 Newsletter. Instead, it represents innovative planning on the part of your Speech Advisory Committee and the State Office.

You will be receiving in October your registration/time preference card for the April 19-20, 1991 State Speech meet. A date for return of the card will be noted. One week after that date, the cards will be divided into requests and 90 will be drawn, by lottery, to fill each time slot of 5:30, 7:00, 9:00, 10:30 and 12:00. You will then be notified, again by postcard, within two weeks of that date when your school will perform.

It is the hope that this will allow you and your students to plan immediately for the State Speech meet and can make the necessary arrangements well in advance of the festival.

JUNIOR UPDATE

Addendum. This year, each returning WHSFA Junior member school will receive an Addendum to be used with the 1988-90 Handbook. New members will receive a copy of the Handbook, the Addendum and the Criticism publication.

Groups are not just for interpretation anymore! This season there are two new opportunities for students to participate in groups of 2 or 3, if they'd rather not go it alone right away.

Demonstration Speaking now has a two speaker option. **News Reporting** is a brand new category for one to three students. (Details are printed in the Junior **Addendum**.)

Thanks to Host Schools; twenty five schools have volunteered to host WHSFA Level I and Level II festivals in 1991. Dates and locations will be mailed to member schools with the Addendum and the Extemporaneous Reading novel for this season.

Farewell to our Junior Advisor, Dr. Larry Weiss. Larry has left UW-Oshkosh to take a position as a Curriculum Coordinator with the Hartford School District. WHSFA Junior Division will miss Larry's contributions, but we wish him well.

COMPLAINT POLICY TO BE INCLUDED IN HANDBOOK

At the direction of the Speech Advisory Committee, the WHSFA policy regarding State Speech adjudicator concerns will be published in the **Handbook/Addendum** under **General Rules:**Speech Competition. The statement will be:

"Any coach of a WHSFA member school may register a complaint regarding a student(s) evaluation(s) by sending a letter which identifies the concerns, with a copy of the critique sheet(s), to the State Office within two weeks after the date of the event. The State Office will forward a copy of the letter and the critique sheet to the involved adjudicator and invite a response. If a response is received, a copy will be sent to the individual registering the concern."

Just a reminder. This process will not result in the change of an award. As stated in General Rules: "Once a ballot has been signed by a judge, no grade or decision on that ballot may be changed except to correct a recording error."

It remains the intention of the Association to provide a vehicle for coaches to inform the State Office of their reservations/concerns regarding individuals being used in the adjudication process.

CHECK YOUR MAILBOX FOR SPEECH QUESTIONNAIRE

It is time to consider new category possibilities for our WHSFA Spring Speech series.

In your mailbox, about the same time as you are reading this, will be a survey which is divided into four parts:

- New category possibilities; i.e. <u>Radio Speaking and Moments in History</u> Rule sheets and critique items for both are included.
- (2) Storytelling changes Rule sheet and critique items are included.
- (3) Review of previous categories Group Discussion/Significant Speech.
- (4) Possible other new categories.

Each area is a separate voting issue. Please review carefully, discuss with colleagues and students and return by the deadline.

STATE SPEECH JUDGE REQUIREMENT

The Speech Advisory Committee and the State Office concurred that asking each school to provide one judge for the State Speech Festival should be continued. However, it is apparent that clarifications of this requirement are necessary. Please review the following, and call the State Office if you have any questions:

- (1) One adjudicator for one round is all that is requested.
- (2) The judge provided can designate which round they wish to adjudicate; i.e., Friday, 5:30, 7:00, or Saturday, 9:00, 10:30, 12:00.
- (3) A choice of either speaking, interpretative or acting will be provided to that individual who is the designated adjudicator from each school.
- (4) Each school should assume that their designated person will be adjudicating during the time the team is performing unless:
 - a. the State Office has sent a letter indicating we were unable to use that individual because of category/district restrictions.
 - the individual has requested a different time slot then when the school providing this person is performing, in which event that person would be confirmed separately.

The State Office continues to invite your suggestions for other qualified individuals to serve as adjudicators for this festival. We also encourage you and them to enroll in the ETN class, "Learning to Speak: Speaking to Learn," The WHSFA Adjudicator Orientation class scheduled for this fall in preparation for the 1993 State Speech festival, when all individuals who serve as adjudicators must have taken this course.

GROUP DISCUSSION PETITIONS RECEIVED

Petition has been received in the State Office urging us to save **Group Discussion** as a category of participation. It was signed by sixty-four individuals, including coaches, judges, school administrators and students representing all areas of Wisconsin.

This petition was instigated by two graduating seniors. Their cover letter to all of us says:

To Whom It May Concern:

As senior participants on the Lodi Forensics team, we, John M. Payne and Roger D. Lovelace, have participated in Group Discussion for the past two years. In these two years, we have been able to see the importance of this category.

Group Discussion is an important part of everyday life and the basic structure of problem solving. People much like ourselves are unable to compete against others without being able to compete with them. By this we mean that we are unable to be a stand up solo speaker, but we are able to communicate and compete with other people successfully.

From this you should be able to see the importance of this category to people like us.

Another petition was received during the summer months, signed by eighteen students also requesting the reinstatement of this category.

Please consider this request when you return your survey questionnaire this fall.

NOTEWORTHY NEWS

Did you see the article "Teachers Guide: Solo Acting," written by Susan Tews of Cumberland High School and published in The Forensic Educator, a publication of the National Federation Interscholastic Speech and Debate Association? It is well written and offers excellent help to coaches who have students interested in this area.

ADDENDUM FOR 1990-1991 TO BE PUBLISHED

The Speech Advisory Committee has made the recommendation to publish a second **ADDENDUM** for the speech series for 1990-91.

The elimination of Group Discussion, the survey regarding new category possibilities, (see related story) and the lack of any major constitutional or General Rule changes made this decision a cost and time saving measure.

Please note the new topic/questions for Public Address and Special Occasion as well as the <u>new</u> Storytelling selections in the **Addendum**.

In addition, an editorial change was made in Demonstration. Rule 2 will now read:

"Objects functions and/or physical activity must be demonstrated by the participant."
