

State Speech Contest

The 1960 State Speech Contest, held on the University of Wisconsin campus on April 9, was attended by 1217 students from 335 high schools; 103 fewer contestants than in 1959. The decrease was primarily due to the merging of the humorous and non-humorous declamation contests into one event called memorized declamation. Among the remaining seven events there was increased participation in non-original oratory, extemporaneous reading, and four-minute speaking. In original oratory, extemporaneous speaking, interpretative reading, and play reading there was a slight decrease.

The following chart compares the number of contestants in the 1959 and 1960 contests.

Mr. Kenneth Curran Resigns

After fifteen years on the Board of Control of the Wisconsin High School Forensic Association Mr. Curran has tendered his resignation.

One who serves a worthy cause beyond the call of duty is worthy of special praise. Such a person is Kenneth Curran, Administrator of Cashton's Public Schools. Mr. Curran served as a member of the Board of Control of the Association from 1944 to 1959.

Mr. Curran was particularly active in supporting a forensic program for all students in small high schools as well as in large ones. He brought to the Board of Control a broad vision and fine sense of humor.

Results of State Debate, Tournament

Fifteen teams competed for top honors in the 1960 State Debate Tournament held at the Wisconsin Center Building in Madison on February 26 and 27. Stevens Point won first place as the only undefeated team in the tournament. Kenosha rated second place with seven wins and one loss. Whitefish Bay and Chippewa Falls McDonell tied for third place with six wins and two losses. Other schools in the event were Hartford, Merrill, Neenah, Wausau, Eau Claire Memorial, Eau Claire Regis, Chippewa Falls Senior, West Bend, Green Bay West, Racine St. Catherine, and Madison West.

A school plaque and individual gold medals were awarded to the Stevens Point team. Certificates of Achievement for the schools and debaters were presented to the second and third place teams.

Mr. Harold Konnak, University of Wisconsin Regent from Racine, was the guest speaker at the banquet held on Friday evening in the Center Building. His subject was "The Spoken Word."

A welcome from the University of Wisconsin Extension Division was given to the students and coaches by Mr. Charles Wedemeyer, Director of Correspondence Study. Mr. Harold G. Gall, Chairman of the Board of Control of the WHSFA, greeted the participants, coaches, and judges at the dinner. Frederick E. Haug, Jr., Secretary-Treasurer of the WHSFA presided.

The official question for the 1959-60 school year was: "Resolved: that the federal government should substantially increase its regulation of labor unions."

New Play List Enclosed

"APPROVED PLAYS 1960" is being sent to you with this Newsletter. All plays to be entered in the one-act play contest in 1960 must be taken from this list, with one exception. Any school may enter an original one-act play (written by the faculty and students of that school); such an original play must be submitted to the State Office by October 1 so that final approval may be granted.

University Summer Speech Institute

On June 30, 1960 the University of Wisconsin Department of Speech and the Department of Education will sponsor a one-day institute on the Madison campus. The subject of the institute will be "The High School and College Theatre--Architecture and Stage Design."

This institute, designed primarily for teachers and prospective teachers of speech, will combine instruction by recognized leaders in the field, and demonstration. The morning program will feature two speakers. The first is Arnold S. Gillette, Director of the University Theatre, State University of Iowa, who has very recently published a book entitled Stage Scenery. The second speaker is Orville K. Larson, Associate Professor in Fine Arts at Ohio University. Professor Gillette will speak on "Scene Design for the High School Theatre," while Professor Larson will discuss "Some Aspects of Contemporary American Scene Design."

In the afternoon Professor Frederick A. Buerki, Theatre Technical Director at Wisconsin, will talk on "High School Theatre Architecture." His speech will be followed by a discussion concerning "Effective Low-Budget Scenery and Lighting for the High School Stage." Participants in this discussion will be Mr. Thomas Tews, West High School, Madison; Mr. Eugene Cramer, Manitowoc High School; and Professor Buerki.

The concluding presentation will be a demonstration of representational and presentational acting. This portion of the institute is being prepared by Miss Jean Scharfenberg, Wisconsin High School, Madison; Mrs. Jane McCartney, Monona Grove High School; and Professor Jonathan W. Curvin of the University

Speech Department. A group of high school students will assist in the demonstration.

Coinciding with the institute will be the opening performance of the Wisconsin Players' first 1960 summer production, The Waltz of the Toreadors by Jean Anouilh.

There is no registration fee for the institute, and anyone interested in the program is most welcome to attend. Tickets for the play in the evening may be purchased at the registration desk on the morning of June 30th. For a copy of the institute program write to Professor Herman H.
